

Agreement Between
New York University, on behalf of its Steinhardt School
of Culture, Education, and Human Development,
And
China Medical University (Taiwan) on the
Enrollment of Graduates of CMU in the DPT-PPT and MA-KIN
Programs in Physical Therapy at NYU

New York University, on behalf of its Steinhardt School of Culture, Education, and Human Development ("NYU"), located in New York, New York, United States, and China Medical University ("CMU") located in Taichung, Taiwan, hereby agree to the following collaboration:

I. Parties to this Agreement

1. The Steinhardt School of Culture, Education, and Human Development, New York University
2. China Medical University (Taiwan)

II. The Program

1. In mutual recognition of the high quality of the academic programs at both universities, the Program shall involve CMU sending graduates who have received the Bachelor's degree ("BS") in Physical Therapy to NYU for graduate degree programs in two areas: 1) the Doctor of Physical Therapy for Practicing Physical Therapists Program ("DPT-PPT"); and 2) the MA in Pathokinesiology Program ("MA-KIN").
2. For the DPT-PPT, NYU may accept up to two (2) graduates each year of the BS in Physical Therapy at CMU.
3. For the MA-KIN, NYU may accept up to four (4) graduates each year of the BS in Physical Therapy at CMU.

III. The Curriculum and Admission Requirements

1. The curriculum
 - a. CMU graduates do not receive any credit reduction for the NYU degree.
 - b. For the DPT-PPT, students must successfully complete 60 (sixty) credits of course work at NYU according to the curriculum in Appendix A.
 - c. For the MA-KIN, students must successfully complete 34 (thirty-four) credits of course work at NYU according to the curriculum in Appendix B.
2. Admission requirements
 - a. For the DPT-PPT, all applicants must meet the NYU admission requirements to be accepted into the NYU DPT-PPT program as outlined on the NYU Steinhardt web site, http://steinhardt.nyu.edu/graduate_admissions/ and

<http://steinhardt.nyu.edu/pt/dpt/pt/admission>. Specifically, applicants to the DPT-PPT must have:

- i. At least a baccalaureate degree or equivalent international credentials in physical therapy;
 - ii. A minimum 3.00 cumulative grade point average;
 - iii. Competence in conveying ideas in an organized manner, to be demonstrated with a written statement of goals related to the DPT Program;
 - iv. Two letters of reference
 - v. Official scores from the Graduate-Record Examination (GRE)
 - vi. Applicants whose first language is not English are required to take the Test of English as a Foreign Language (TOEFL) or equivalent examination.
 - vii. Applicants from foreign countries must submit evidence of licensure, or equivalent permit for practice in one's country, with the application.
- b. For the MA-KIN, all applicants must meet the NYU admission requirements to be accepted into the NYU MA-KIN program as outlined on the NYU Steinhardt web site, http://steinhardt.nyu.edu/graduate_admissions/ and http://steinhardt.nyu.edu/graduate_admissions/guide/ptph/ma/kin, with the exception of the requirement of one year of clinical experience, as noted below. Specifically, applicants to the MA-KIN must have:
- i. At least a baccalaureate degree or equivalent international credentials in physical therapy;
 - ii. Resume or CV
 - iii. Statement of Purpose
 - iv. Two letters of reference
 - v. Applicants whose first language is not English are required to take the Test of English as a Foreign Language (TOEFL) or equivalent examination
 - vi. Official Transcripts
 - vii. The GRE is not required
 - viii. The general admissions requirement of one year of clinical experience will be waived for CMU applicants to the MA-KIN.

IV. Time Frame and Application

1. The first group of students under this agreement will start at NYU in fall semester 2017.
2. NYU's application form for the program is available at http://steinhardt.nyu.edu/graduate_admissions/.
3. All applications must be completed and submitted to NYU by the published deadline, which is currently February 1 of each year.
4. NYU will notify CMU and each accepted student of such acceptance by April 1 of each year.

V. The Cost of the Program

1. The rate of tuition for the academic year of 2015-2016 at NYU's Steinhardt School of Culture, Education and Human Development is \$1,538 per credit, plus all applicable fees. Tuition will

increase by approximately 5% to 7% each year and therefore the tuition payable for the Program shall be subject to change.

2. Each student will be personally responsible for the tuition and all applicable fees including, but not limited to:
 - a. registration fees and comprehensive health insurance required by NYU
 - b. all living and personal expenses, including, without limitation, housing and board, and immigration.

VI. Visa Application and Comprehensive Health Insurance

1. CMU applicants will apply for appropriate U.S. visas and shall be solely responsible for all immigration and visa matters.
2. CMU applicants are required to comply with New York State Public Health laws that mandate vaccinations for measles, mumps, rubella, and meningitis, and must participate in and pay all fees for NYU's Comprehensive Student Health Insurance plan. Evidence of compliance with this Section shall be provided to NYU prior to admission to the Program.

VII. Term of this Agreement; Termination

1. This Agreement shall have a term of five years (Fall 2017 – Summer 2022) and may, upon further written agreement of the parties, be renewed for successive terms.
2. Upon the occurrence of a breach of any term of this Agreement, the non-breaching party may give notice to the breaching party and the breaching party shall have thirty (30) days in which to cure such breach. If such breach is not cured during such period, the nonbreaching party may upon further written notice to the breaching party terminate this Agreement.
3. Either party may terminate this Agreement upon ninety (90) days prior written notice to the other party.
4. Notwithstanding the foregoing, no student who has fully paid for the Program shall be affected by any termination of this Agreement.

VIII. Miscellaneous Provisions

1. All NYU policies and procedures shall apply to the CMU graduates enrolled in the Program.
2. All notices, consents, payments, demands, requests, and other communications required, desired, or permitted to be given under this Agreement shall be in writing and shall be deemed "given" when delivered by messenger or when deposited in the United States or Chinese Mail, certified or registered, return receipt requested, with first class postage affixed, addressed as follows:



3. Neither party will use the name, logo, trademark or other designation associated with the other party, or any of its respective schools, colleges, divisions, departments or other units, for any purpose, including without limitation for marketing, advertising or publicity materials, without the prior written consent of the other party.
4. Each party agrees that, in connection with the evaluation of students in the Program covered by this Agreement and the administration of such Program, such institution shall not discriminate against any person on the basis of race, color, religion, sex, sexual orientation, marital or parental status, national origin, age, citizenship status, or disability.
5. This Agreement may only be amended by written agreement signed by both parties.




