



MEMORANDUM OF UNDERSTANDING

CHINA MEDICAL UNIVERSITY SCHOOL OF PHARMACY, TAICHUNG, TAIWAN
AND
UNIVERSITY OF CINCINNATI, THE JAMES L. WINKLE COLLEGE OF PHARMACY, CINCINNATI,
OHIO, U.S.A.

On behalf of China Medical University School of Pharmacy (CMU), Dean Wen-Chuan Lin and on behalf of University of Cincinnati (UC), the James L. Winkle College of Pharmacy, Dean Neil MacKinnon agree that cooperation between these two institutions would foster coordinated education, student and fellow training, and faculty research collaborations of mutual interest in the areas of Patient Safety and Outcomes Research, and to explore opportunities for clinical pharmacists from Taiwan to complete the Winkle College of Pharmacy's online graduate certificate and MS programs with an emphasis on Clinical Pharmacy and Leadership. Cooperation will include, subject to mutual consent, any activity to further scientific and academic interactions between CMU and UC, to complement their respective areas of expertise and to enhance their mission for the advancement of pharmaceutical care research. Such cooperation may include:

1. Short-term training for CMU Clinical Pharmacy faculty members and students.
2. Master of Science (MS) degrees, either non-thesis or thesis, in Outcomes Research.
3. Joint research projects in areas pertaining to Clinical Pharmacy, and Outcomes Research.
4. Dual MS degrees in Health Outcomes, and Pharmacy Clinical and Leadership (upon approval).
5. Short-term visits for lectures, conferences, workshops, and seminars.

The parties will enter into specific written agreements hereunder to clarify and define the nature of the terms of operation for the collaboration and cooperation between the including academic terms, intellectual property ownership, and funding before the academic year of 2018-19.

This MOU shall take effect when signed by the official representatives of the institutions involved and will remain in effect for an initial period of five years and may be extended by mutual agreement in writing for additional five years period. Either Party may terminate this MOU with six (6) months written notice of intent to terminate. Any modification shall require the prior written approval of CMU and UC or their designees.
