What we’re looking for: A story told in words and photos to present the

“Study in Taiwan”

Qualification: International student who’s currently studying in
university or graduate school in Taiwan. Each participant
is allowed to submit one piece only.

Important dates:

1. Submission dates: From October 1st to October 21st midnight.
No amendment is allowed after submission.
2. Evaluation time:
 - (1) First round: November 1st to November 7th
 - (2) Final round: November 8th to November 14th
3. Announcement: Announcement of the winner will be made on
our website on November 20th

Contents:

1. A story in either English or Chinese. Word limit: 400.
2. A title that suits the content of the story.

3. A photo that relates to your story. A photo that can further express your feeling and emotion is highly recommended.
4. Both story and photo should be made by the students themselves without the help of others, and should not be published openly.

Prize:

1. Top 3 Award: A certificate of recognition and convenient store gift coupon equivalent of 2500NTD, 2000NTD and 1500NTD according to their ranking.
2. 7 Award of Eminence : A certificate of recognition and convenient store gift coupon equivalent of 1000NTD.
- 3.10 Selected Award: A certificate of recognition and convenient store gift coupon equivalent of 500NTD.

Evaluation standard: Creativity 40%, Theme 40%, Grammar and structure 10%, Photo 10%

Evaluation process:

1. First round (November 1st to November 7th, 2012): The project specialists of FICHET will choose the best 20 pieces among all the submitted works.
2. Final round (November 8th to November 14th, 2012): Three experts will evaluate the works and decide which pieces won the Top Awards, Award of Eminence, and the Selected Awards.
3. Evaluation criteria: Creativity 40%、Theme 40%、Structure and

grammar 10% 、 Photo 10%

Prizes:

1. Top three Award: The top three award winners will be awarded with a certificate of recognition and convenient store coupon equivalent of 2500NTD, 2000NTD and 1500NTD according to their ranking.
2. 7 Award of Eminence: The seven Award of Eminence winners will be awarded with a certificate of recognition and convenient store coupon equivalent of 1000NTD.
3. 10 Selected Award: The ten Selected Award winners will be awarded with a certificate of recognition and convenient store coupon equivalent of 500NTD.

1. The winners will be announced at the Study in Taiwan website (<http://www.studyintaiwan.org>) on November 20th.
2. By submitting your work, you agree with all the policy of this event. On the infringement of plagiarism, fraud or other illegal behavior, FICHET reserve the right to cancel the qualification, prize, and certificate, and to pursue legal liability.
