About financial statement, if the applicant cannot obtain verification from the Overseas Office of ROC, the documents could be sent, in sealed envelope, from the institutions concerned to our Office of Admissions. However, if CMU has any doubt about the documents, the applicant must consent to seek verification from the Overseas Office of ROC.
